Everything is ready to meet 180 business leaders of South Eastern Europe

During the two days, 1st and 2nd June, Portorož (Slovenia), will host the most prominent business and political leaders from across South Eastern Europe. The focus of the talks will be the most propulsive sectors - from energy, knowledge-based economy, tourism, F&B, digital economy to transport and infrastructure, with the clear positioning smart cities in economic development.

On behalf of the Summit100 Organizer, The Managers' Association of Slovenia - MAS, its president, Aleksander Zalaznik, believes that "the renewal and strengthening of economic relations is an important contribution to the stability of South Eastern Europe and for more successful economies countries, within the area. and the competitive potential of the whole of South East Europe.

Such a commitment is confirmed by the CEO of Atlantic Group, Emil Tedeschi, stressing that Summit 100 shows once again that the business community has always been and remains a step ahead of politics, which is why the meeting is an important incentive for dialogue on economic co-operation in the region, for which there is space and the need in various fields, not only infrastructure, telecommunications and energy projects.

"The fourth annual gathering of employers and entrepreneurs of South East Europe continues with the idea of gathering and sharing business representatives in order to be a durable platform and meeting place for the most distinguished entrepreneurs and businessmen from Slovenia, Croatian, Serbia, Montenegro, Bosnia and Herzegovina, Macedonia, Kosovo and Albania", proposes Vice President of the Summit100 Management Board, Damir Kuštrak.

"The initiative of voluntary organisations of employers – the Serbian Association of Managers, the Croatian Employers Association and the Managers' Association of Slovenia - MAS, and fully supported by the Atlas Foundation Montenegro - remains unchanged, and concerns opening perspectives for strengthening the competitiveness of national economies of countries, but also competitive potential of the entire southeast of Europe. The gathering is linked to the process Brdo-Brijuni, which, parallel to the summit, held a



meeting of Heads of State of the region, the highest political leaders in the region to jointly open the perspective of strengthening the economy. Overall, the variety of political tension in the region that we are aware of late, economists promote co-operation, the possibilities of expanding markets and joint

appearances on third markets", concludes Kuštrak.

Summit100, as was vividly iterated by Dr. Iztok Seljak, Chairman of the Management Board, must discuss the future in which there is a project for the development of high-speed rail on the platform of Smart Cities of South Eastern Europe. "We need to be able to sit down in a high-speed train in Ljubljana and a half hour later get to Zagreb and after a further hour and a half to Belgrade, and for the next hour and a half to Skopje. Then the region will actually be much better strongly connected".

The patron of this year's events, the Slovenian President, Boris Pahor, who will host his fellow presidents from Croatia, Bosnia, Montenegro, Kosovo and Macedonia - Kolinda Grabar Kitarović, Mladen Ivanić, Filip Vujanović, Atifete Jahjaga and Gjorge Ivanov.

Summit100 was first organised in 2011 in Serbia, the second year in Montenegro, and the third in Croatia, and all three had Presidential patrons from the host country.

New investment plan for Europe

Over the course of the next three years, we should be seeing investment of up to €315 billion that could create 1.3 million new jobs across the EU. This is the basis of the plan by the President of the European Commission, Jean-Claude Juncker, for economic recovery in the EU.

Basically, the Juncker plan has a multiplier effect; each $\in 1$ of public money from the budget could be turned into $\in 15$ in order to attract private investors. If this succeeds, Juncker could reverse the course of the crisis in Europe. If he cannot leverage in this manner, the entire construction plan could collapse. Rather than wasting European budget money directly on infrastructure pro-

jects, Juncker plans to use the budget money as a guarantee in the hope that private investors contribute. That could mean €21 billion, which should raise EU funding to €315 billion.

There will be particularly interesting panel on which to discuss the possible use of resources in the region, and how it can help strengthen the economies of the countries of South Eastern Europe.





Women leaders will have a special place during this years Summit, a special side-event being organised by Women-leaders Section at Managers' Association of Slovenia with H.E. Kolinda Grabar-Kitarović, President of the Republic of Croatia.

"Women are still insufficiently represented in senior leading positions where decisions are made. The percentage of women on supervisory boards (15%) in Slovenia is only slightly higher that the European average (14%). However, the level of women in government is as low as 8%, which is much lower than the European average (26%). Luckily, positive trends may be seen.

In 2004, 10% of women were on supervisory boards, in 2014 there were 15%; in 2004 24% of managerial positions were held by women, in 2012 27%". Nevertheless, current numbers remain unsatisfactory", pointed out P. Danica Purg, President of the IEDC-Bled School of Management, Slovenia, and President of CEEMAN, the association of 219 management development institutions from 54 countries.

As an introduction to Summit100, a presummit event for top young leaders under 40 will take place, with a special address from Mr. Petar Kraljič, a globally recognised consultant.



Dr. Peter Kraljič, Director Emeritus of Mc-Kinsey & Co. Inc, joined McKinsey in 1970. He was promoted to Principal in 1977 and to Director in 1982. He was, for a number of years, a member of McKinsey's Shareholders, Firm Development and Personnel Development Committees, and from 1993 to 1998 managed McKinsey activities in France. Prior to joining the firm, he worked for six years in metallurgical research with

companies in Yugoslavia, Germany and Luxembourg.


Of late, Dr. Kraljič has been leading special projects aimed at economic growth and job creation in Germany and Brazil. He also led a project looking at the attractiveness of Central and Eastern European countries for foreign direct investments, based upon a set of macro- and micro-economic criteria.
